They own military forces which consist of soldiers and spies. Many of them collect taxes on various shops and business and murder people who refuse to pay their taxes. They are literally at war with the US Government and they also make money by murdering, terrorizing, and robbing US Citizens. How is that not a Kingdom?

Capped is a street slang term for murdered with a gun.

Now people who are ignorant might say being a king is just an expression that rappers use. However to be a King all you need is to collect taxes from people and to own a military force that enforces your kingly authority and to kill anyone who threatens said authority. When gangsters tax shops and businesses (commonly called extortion or a protection scam) they don't even hide the fact they're paying taxes. They even call it taxing them and call the money being paid to them paying taxes.

When a rapper calls themselves a king this is not an expression this is reality. What gangsters call a "game" is also what they do and when you forget "the game" is not a game at all they might use an expression like "Do you think this a game?" which means submit to me or violence and possibly death will be enforced right now.

There's no refuting it. We have kings in America. These kings have armies of soldiers and spies. Members of our own government who can be corrupted even protect the kings including state government employees like police and even on a federal level such as FBI can be bought by the kings and more loyal to them than they are to their own government. Kings collect taxes, conduct wars against the US Government that involve murdering government employees and murdering and enslaving USA citizens and even charge USA citizens taxes and make payment of them mandatory under penalty of death.

Some kings even take US Citizens as young as 8 years old as slaves and sex or human traffick them although the average age for child sex slaves between 8 and 17 in America is 13. Most children who are trafficked by crime syndicates do not live into adulthood, because at a certain point their usefulness as a commodity expires with their age and they become a liability to said organizations, but the average lifespan is 7 years. Really street crime wars are not that different from regular wars. There are Kings in America, and if you challenge their authority as kings in a way they feel threatens them (or sometimes just insults them) they will murder you for it.

I don't know what President George W Bush (JR) was talking about with the concept of starting a "New World Order." That term is an antiquated term taken from thousands of years ago originating from the Anglo Saxons that continues to pop up in history again and again as it is recycled and used by new parties. However in America the New World Order is not the US Government. It's a criminal organization and their usage of the hexagram is not Judaic. Most crime syndicates in America have government employees even on a federal level on their payroll, because this is a very corrupt country and they need these connections who are more loyal to their syndicate than they are to the government that pays their legitimate salary. This doesn't mean the New World Order and the US Government is the same thing. President Bush Jr's usage of the term is likely coincidental as it is an ancient term that people keep adopting and recycling throughout history.

The New World Order is real. The Kings of America are real. They aren't run by the US Government though. They're tolerated by the US Government in a Country where crime is out of control, and some of them basically own members of the US Government who are more loyal to them than they are the US Government they allegedly work for. The Kings and The New World Order and really any other type of gangster crime syndicate who owns an army of soldiers and spies operate in many ways like a government does. In America (but not all Countries) the rules of engagement that apply to warfare between Countries are usually similar and often exactly the same as warfare between crime syndicates and each other or the US Government.

Remember folks, snitches get stitches. What I'm doing may seem like snitching, but really most of the information I'm sharing is just standard street knowledge combined with a little publicly available research online. Nothing is new about what I'm saying and what most people with a little street wisdom know except for the style in which I am presenting it.

Also remember Ferguson. An important lesson was learned here when people came from outside the city of Ferguson to riot and raid shops to justify the US Government declaring Martial Law on the city. The US Government and the police did not protect any shops from the rioters, but the criminals who ran extortion AKA "protection scams" on various businesses protected the shops that paid them taxes. So remember to choose your sides wisely. Paying taxes to crime syndicates or to gangsters is always mandatory, but remember when the US Government pays people to come into your city or state and attack the shops there the people who also pay taxes to the gangsters will be the only ones protected. The purpose of tolerating Kings, The New World Order, or any other crime syndicate or criminal organization is of course that many people want to be protected from this Country's actual government. I could write a book on this and how it works but to sum it up the lesson of Ferguson expands into other areas. Some people want to do minor things which are illegal, like drugs for instance. They need someone else to be in charge of distribution of the drugs so they don't have a liability. Therefore these people tolerate the existence of crime syndicates, because the US Government has outlawed their presence. A majority of people in prison are non-violent offenders guilty of things like drug use. They'd rather go to jail than snitch since snitches get stitches (or realistically often die) for snitching and they know they'll continue to use if they get out by snitching.

It's also important to remember that prisons, and sometimes jails, are not run by the US Government. They're not even run by the corporations who own the prison systems and profit off the imprisonment of nonviolent offenders who end up there. In reality and actual experience most prisons and many jails are run by the criminals who live in them. This is another reason why people don't snitch on criminal enterprises when there is no guarantee they won't do jail or prison time for their offenses. Many kings don't stop being kings when they go to prison. Many of them simply run their enterprises from behind bars and / or run the prisons themselves.

The lesson in both of these instances is the same. Some people are simply immoral, others simply have different moral codes and disagree with the government on things like drug use or prostitution. However for whatever reason many people in low income areas or other areas where crime flourishes need some way to be protected from the government just like the shop owners needed a way to be safe from the rioters in Ferguson hired by the US Government. Some of these people may see themselves as a greater victim at the hands of the US Government than they are at the hands of gangsters and any criminal organizations or crime syndicates and would therefore prefer to take sides with the criminals over the government.

As you can see there are a lot of realities here about why crime still exists in this Country. People tolerate criminal syndicates for a variety of reasons. Most of these reasons could be eliminated with some changes to our laws and current structure of government that aren't entirely unrealistic. Some of the services crime syndicates provide could be realistically provided by our government.

I.E. People tolerate pimps and gangsters who provide prostitution services, and use terms like "sex worker" to show their support of said criminals, yet those same people neglect to notice the rape of not only sex workers but also snitches and other enemies, the poor treatment nearly equivalent to slave treatment of sex workers, the sexual exploitation of children and literal human trafficking that goes with it. If prostitution and some limited drug use were legalized and therefore regulated by the US Government crime syndicates would not have nearly so much support from the common man, and the abuse and mistreatment that comes with the fact only criminals are involved with these things would be eliminated in these areas. However for as long as these reasons to tolerate crime syndicates exist crime syndicates will continue to flourish.

There will always be the risk of crime and crime syndicates for things a majority of people see as immoral designated as crime. Obviously for example in regulating drugs the government shouldn't be selling date rape drugs just to stop criminals from competing. However as long as things large amounts of people don't see as immoral are illegal crime syndicates will continue to flourish and be tolerated and the greater evils they provide that come with putting these things in the hands of criminals will continue to be tolerated by association. A key to reducing crime involves in large part what you are criminalizing not just how much money and power you give to law enforcement and the executive branch.

While I'm still on the soap box there is actually no valid evidence that the practice of paying police and law enforcement personnel small salaries prevents corruption. Many Countries with far less problems with crime than America believe the opposite and prove a reality to this by paying law enforcement higher salaries. It is an established fact in many Countries that law enforcement being paid a salary that accurately reflects the fact they are putting their lives on the line discourages and prevents corruption.

Another benefit to a realistically higher salary for law enforcement is that said jobs can then require a higher education and training. Educated people with higher intelligence who are paid a higher wage are less likely to be corrupt or outright incompetent which is frankly two widespread problems in law enforcement in America on both a state and federal level.

Racists are statistically less intelligent and less educated than your average American, and the act of requiring a higher intelligence level or higher education eliminates racists from being eligible in the first place. Throw in a few mandatory full courses on the logic behind the fallacy of racism and the more intelligent racists can be turned away from the cause and the less intelligent ones turn away from joining the establishment. A person is even willing to pay for a higher education as well as spend the time it takes to get one for years if they will make a higher salary on the job.

This also weakens crime syndicates since they would need to raise a much higher amount of money to bribe said officials and would find themselves routinely weakened by the more educated better paid law enforcement community where incompetence and corruption is far less widespread by default and most shadow organizations and governments therefore lose power by default.

We can afford to spend over 50% of taxpayer money on war. Why can't we afford to spend more on the wars taking place in our own Country and the criminal enterprises with military forces of soldiers, spies, and tax collectors who operate very much like the foreign governments in the wars that get this funding?
